**The Undersigned agrees to the payment terms selected above, and the General Provisions following:** The undersigned hereby makes application to Ernie's Fueling Network, L.L.C. ("EFN"), a D/B/A of Ernie's Cardlock, L.L.C., for credit and/or updates and confirms existing account(s) for purchases made or to be made under its EFN cardlock account. This agreement covers all charges on the EFN account for purchases from participating vendors within the CFN and/or PP cardlock systems. EFN provides the undersigned with services, which include credit, cardlock access to a network of automated fuel sites, and a fuel management system. This agreement shall apply to future credit (if any) by EFN to the undersigned, together with any existing indebtedness undersigned owes to EFN. EFN is authorized to request, regarding the undersigned and guarantor, a credit report and information from bank and trade references to evaluate and update credit worthiness. In the event the undersigned fails to pay any balance when due, the balance shall accrue interest at eighteen percent (18%) per annum from the due date until paid in full. Payments shall be applied first to interest charges, then to principal. In the event the past due balance is referred for collection, the undersigned agrees to pay all costs of collection, including collection fees (up to the maximum amount allowed by law), actual attorney's fees and court costs, regardless of whether suit is filed. The undersigned agrees to abide by the credit terms of EFN as established and amended from time to time upon fifteen (15) days written notice. If a lawsuit is commenced, the undersigned agrees such shall take place in Pierce County, Washington or for Canada residents or Canadian companies, in the Province of British Columbia. The undersigned agrees that this Credit Agreement shall be governed by the laws of the State of Washington, or for Canada residents or Canadian companies, the laws of the Province of British Columbia. If the undersigned sells, transfers or changes the ownership or legal structure of its business, the undersigned agrees to provide written notice by registered or certified mail to EFN's general manager. Until EFN receives such notice, the undersigned agrees to pay for all purchases made on all account(s) established in its name, for all purchases made by any person using cardlock cards issued to, or for the benefit of, the undersigned, including unauthorized and fraudulent purchases. You may be liable for the loss, theft, or possible unauthorized use of your fuel access card. You will not be liable for unauthorized use that occurs after you notify EFN of loss, theft, or possible unauthorized use, and you receive written confirmation that your notification was received by EFN. If your organization has ten or more valid EFN fuel cards for use by your employees, at this time or any future time, you hereby agree to be liable for all uses of your EFN fuel access cards, both authorized and unauthorized, prior to notifying EFN of a lost or stolen card or unauthorized use. Written confirmation is required for proof of notification. Faxed documents shall be considered the same as originals; however, the undersigned agrees to use its best efforts to provide EFN original documents as soon as possible. The undersigned warrants and represents that the information provided to EFN is true and accurate and acknowledges that it has been given for the purpose of obtaining credit from EFN.
